

VIRGINIA, STAND UP FOR JESUS!

State-wide election on Tuesday, November 3rd, 2009

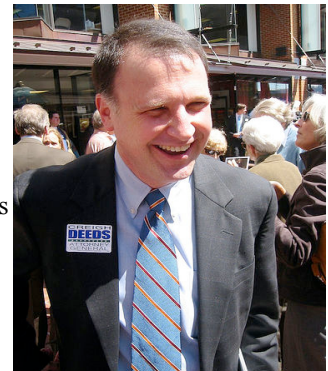
This non-partisan voter guide does not endorse any candidate or party for public office. Neither does it oppose any. It merely reports how candidates voted on many issues, like: Do Virginia State Trooper Police Chaplains have the right to pray publicly “in Jesus’ name” or pray according to their own conscience? You may recall reading the national news in September 2008, how outgoing Virginia Governor Tim Kaine’s administration created a new policy forcing all 17 State Trooper Chaplains to stop using the word “Jesus” in their public prayers, directly ordering Chaplains to either pray “non-sectarian” prayers that don’t mention Jesus, or be forced with exclusion from participating in public events. 6 of the 17 State Trooper Chaplains turned in their badge and resigned, rather than deny Christ or water-down their public prayers. So 86 VA Pastors wrote, and 1,000+ Christians rallied for Jesus at Governor Kaine’s mansion, demanding he reinstate the 6 Troopers to their Chaplain jobs, and protect their right to free religious expression, but Kaine refused. So the Virginia House successfully voted 66-30 to reinstate the Police Chaplains jobs and right to pray “in Jesus’ name.” But the Virginia Senate (Courts of Justice Committee) voted 10-5 to forbid them from praying publicly “in Jesus’ name” mandating “non-sectarian” prayer content, making the word “Jesus” illegal speech in public prayers. This election determines the Chaplains’ fate. Here’s how they voted:



As Attorney General, Bob McDonnell supported State Police Chaplains right to pray publicly “in Jesus’ name” by endorsing HB 2314.

CANDIDATES FOR GOVERNOR OF VIRGINIA

As State Senator, Creigh Deeds voted against HB 2314 and forbid State Police Chaplains their right to pray publicly “in Jesus’ name.”

The United States Supreme Court has recognized that “churches frequently take strong positions on public issues including...vigorous advocacy of legal or constitutional positions. Of course, churches as much as secular bodies and private citizens have that right.” *Walz v. Tax Commission*, 397 U.S. 664, 670 (1970). The IRS further recommends that tax-exempt organizations distributing voter guides should explain voting records in a broad manner involving multiple major legislative issues involving a wide range of subjects. To ensure this Virginia election voter guide is not too narrowly tailored, we specifically include the following useful information that will inform you, impartially and factually, about the voting record of all Virginia State Delegates and Senators, on many wide-ranging subjects, including many of the following broadly diversified issues:
